EDITORIAL NOTE

THE LAW SCHOOL

Expected exigencies of the national defense program coupled with the demands of the Selective Service Act have necessitated several adjustments in the Iowa Law School. To meet the problems created by students drafted who would otherwise graduate during the present year, provision has been made for these students to graduate in February, provided sufficient summer session work was taken to satisfy the minimum requirements for a law degree. For those not called, the second semester must be completed to meet the usual residence requirements, even though enough course credits may have been earned for graduation. If called during this latter time, they will be able to graduate in June upon the work completed. Mid-year examinations in every subject will provide the necessary completed units of credit for a semester's work.

Reflecting most strikingly the nation-wide shrinkage of college enrollments, the new freshman law class numbers 57, approximately half the size of last year's class. However, the junior and senior classes were less severely cut, remaining at 60 and 74 respectively, and thus bringing the School's total fall enrollment to 191. At the June Commencement 56 members of the class of 1941 received the degree of Juris Doctor, followed by eight others at the close of the summer session in August.

Professor Clark M. Byse, teacher of the courses in Equity, Administrative Law, and Constitutional Law, and faculty advisor to the *Iowa Law Review*, has secured leave of absence to join the Securities and Exchange Commission for a year in Washington, D. C. Similarly accepting a temporary position in Washington, D. C., was Professor Lehan K. Tunks, teacher of the courses in Business Organizations, Corporate Finance, Corporate Reorganization, Taxation, and Income Taxation. After serving as visiting professor of law at Northwestern University's second term of summer session, Professor Tunks joined the Office of Price Administration and Civilian Supply. Professor Frank R. Kennedy will conduct the courses in corporation law during Professor Tunks' leave of absence.

Mr. Jerre S. Williams, A.B., University of Denver, 1938, LL.B. Columbia University, 1941, is the most recent full-time appointee to the faculty of the Iowa Law School. During his undergraduate law school career Mr. Williams served on the Board of Editors of the *Columbia Law Review*, and, during the leave of absence of Professor Byse, Mr. Williams will be the faculty advisor to the *Iowa Law Review*. In addition, he will take over the courses in Equity, Administrative Law, and Constitutional Law.

Dean Mason Ladd during July and August addressed the state bar associations of Tennessee, Idaho, Montana, and South Dakota on the subject of modern developments in the law of evidence. During the Montana meeting he was elected an honorary life member of the Montana State Bar Association. The Dean continues as an advisor to the American Law Institute in its work of drafting a model Code of Evidence and also as legal representative of the Committee on Professional Education of the Committee of the American Council of Education.

Professor Philip Mechem is completing a third edition of his *Cases on Agency*, to be published by Callaghan & Company in early December. Professor Rollin M. Perkins, in addition to his advisory work with the American Law Institute on the Restatement of Security, likewise has written a book to appear within the next few months. It is entitled *Elements of Police Science* and will be published by the Foundation Press, Inc. Professor Clarence M. Upde-

graff was a guest speaker, along with Dean Ladd, before the South Dakota Bar Association in August. Professor Updegraff has also been appointed chairman of the roundtable discussion on labor law to be held at the annual convention of the Association of American Law Schools in Chicago next December 27, 28, and 29.

The summer session of 1941, attended by 86 students, was highlighted by a series of practical courses not ordinarily obtainable in the regular curriculum. Courses in Probate Practice, Examination of Abstracts of Title, Landlord and Tenant, Office Practice, and Bankruptcy formed a unique unit of law school instruction departing from the classic academic routine. In the field of public law and administration, Municipal Corporations, Labor Law, International Law, Trade Regulation, Income Taxation, and Legislation constituted another interesting group. The standard courses in Wills and Iowa Public Utilities were also offered. Professor Perkins again directed the Iowa Peace Officers' Short Course in its fifth annual program, the record enrollment of 360 convening during the week of July 8.

The two annual Dillon Prizes awarded to members of the Editorial Board of the *Iowa Law Review* whose contributions to the Review during the past year are considered the most outstanding went to C. Neil Johnson, Manchester, Iowa, of the senior class, and to John A. Gillotti, Des Moines, Iowa, of the junior class. The fourth annual Nathan Burkan Memorial Prize of \$100 was awarded to Edwin B. Earnest, Elmira, Missouri, for his paper on copyright law.

Initiates of the Order of the Coif drawn from the scholastic upper ten per cent of the graduating class of 1941 were: Robert L. Brooks, Robert S. Fousek, C. Neil Johnson, Corwin W. Johnson, W. Howard Mann, John P. Mansfield, Walter L. Reitz, Jr., and Richard K. Smith. Senior students participating in the fifteenth annual Supreme Court Day moot argument before the entire Iowa Supreme Court, convened for the day on the Iowa campus, were: Richard W. Beebe, Robert C. Fisk, Robert S. Fousek, and Elwood H. Olsen.

This last year's graduating class was generally all located by August. Members of the Class of 1941 entered various branches of military service, the Federal Bureau of Investigation, various departments of governmental administration in Washington, with a fewer number entering the private practice of law. The year was unusual in that the demand for Iowa law graduates could not be filled, either for opportunities in private practice or in governmental or other quasi-legal service.
